INTRODUCTION

The threat of terrorism and the means to fight it efficiently with full respect of the rule of law and human rights is the concern of policy makers, law enforcement agencies and population at large. Operations conducted by many states within the framework of the so-called "war on terrorism" in recent years "have shown that a wide range of human rights are affected by counter terrorism measures, notably the right to life, the prohibition on torture or inhuman or degrading treatment, the right to liberty and security, the right to a fair trial, and respect for private and family life".¹

Counter terrorism and radicalisation measures should respect, promote and ensure the protection of human rights. As stated by the United Nations Human Rights Council in its resolution 31/30 "the objectives of countering terrorism and of the protection and promotion of human rights are not conflicting but complementary and mutually reinforcing"². Policies which are compliant to human rights standards uphold the values that terrorist groups endeavour to destroy, weaken support for radicalism among potential advocates, and reinforce public confidence in the rule of law.

The impact of terrorism and of counter terrorism measures on children is heightened due to their age and vulnerability. Children have been subjected to indoctrination and have witnessed and experienced, within terrorist groups, extreme violence with important risks of lasting physical and mental harm.

Regardless their role in these groups or whether they were the ones recruited or it was their parents who were involved, every child up to the age of 18, should be entitled to all her/his rights established in international law and the principle of the best interest of the child must be a primary consideration in all action related to them³.

In this context and in the scope of supporting regional dynamics around the prevention and the countering of radicalisation, violent extremism and terrorism, the Council of Europe organises a Regional Conference on Countering Terrorism and Violent Extremism: Towards a Human rights Coordinated approach within the framework of the European-Union and the Council of Europe joint programs, the *Regional Support to Reinforce Human rights, Rule of Law and Democracy in the Southern Mediterranean Program* (South Programme IV) and the *Support to Independent Bodies in Tunisia Project* (PAII-T).

OBJECTIVES AND CONTENTS OF THE CONFERENCE

The Conference has two objectives. The first is to establish the basis for a HELP⁴ regional training on repatriation, reintegration and rehabilitation of children in their countries. The second is to present two HELP contextualised courses on Counterterrorism and Violent Extremism, i.e Radicalisation Prevention and Combatting Hate Speech in the Audio-Visual Sector.

1/ Establishing a HELP Regional training on repatriation, reintegration and rehabilitation of children in their countries

Repatriation, reintegration and rehabilitation of children are among the challenges that many countries are facing. Due to the importance of reinforcing a regional and international cooperation on the matter, a regional training including South Mediterranean countries will be developed and conducted during 2022-2025 as part of the regional activities of the Council of Europe. The training will mainly include legal, prison and probation, child protection and social professionals.

Within this framework, the first day of the Conference aims at constituting a basis for this regional training with the expertise and practices presented. The first introductory part will focus on links between transnational crime and terrorism, transnational crime as a way of financing of terrorism, and trafficking in human beings, especially of women and children, as one of the offences committed by terrorist groups on victims. This introduction paves the way for presenting the protection approach in dealing with children linked to terrorism, especially in their repatriation, reintegration and rehabilitation.

2/ Presentation of HELP contextualised courses on Radicalisation Prevention and on Combatting Hate Speech in the Audio-visual Sector

The second day will present the HELP Programme, its network, courses and methodology, The aim is to support primarily legal professionals to apply the international, European and national **human rights standards** in practice. HELP can also be used as a regional tool for trainings. The presentation will also cover how contextualised courses on Radicalisation Prevention and Combatting Hate Speech in the Audio-visual are developed and conducted. Because of the importance of the human rights approach in preventing and countering radicalisation, violent extremism and terrorism there will be presentations on the norms of the European Court of Human rights (ECtHR) and of the European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT) on the issues.

A. Introduction to HELP Program

Human Rights Education for Legal Professionals (HELP) is the Council of Europe training programme that aims at enhancing the capacities of legal professionals and other multisectoral professionals on human rights subjects and on the promotion and protection of human rights in their daily work.

HELP program has two components:

The training component that is hosted by HELP e-learning platform. The access to the courses is free and open to anyone creating an account on the platform https://help.elearning.ext.coe.int/.



It includes online free trainings on human rights issues developed by top Council of Europe experts in different subject matters like Radicalisation Prevention, Combatting Hate Speech and Hate Crime, Combatting Trafficking in Human Beings, International Cooperation in Criminal Matters, Child Friendly Justice, Cybercrime, Combatting Violence against Women, Prevention of Torture and Ill Treatment,





Data Protection, etc. Since 2015, they also cover the EU legal framework and relevant case-law of both the European Court of Human Rights and the Court of Justice of the European Union.


- **The networking component** through HELP Network, is the only European peer-to-peer Human Rights Training Network. It is composed of representatives of National Training Institutions for Judges and Prosecutors (NTIs) and Bar associations (BAs) and also of other multisectoral institutions like National authorities working on different human rights subjects like countering terrorism, combatting trafficking in human beings, prevention of torture, etc

HELP Training Methodology: A HELP training is composed of:

- a **General Course** on international and European standards and best practices, in a specific human rights theme, that is open to public in a self-learning mode, and
- a **Contextualised Version of the Course** on national institutional and legislative framework with practitioners' best practices that is open to a specific group of professionals who are trained by a certified national tutor⁵

How contextualisation is conducted:

The **General course** is first developed in English and then <u>translated</u> into the language of the country that is going to contextualise it.

These groups of certified tutors conduct contextualisation meetings (generally 2 months). The group in charge of the contextualisation is generally composed of professionals from different sectors to guarantee a comprehensive approach to the adapted course.
